Directions: To get to the Southern California Railway Museum, take the 215 freeway south out of Riverside. Take the 4th Street exit and merge onto west HWY 74. From the south, take I-15 to I-215 and take the 4th Street exit. Turn left onto South A Street. The Museum's address is 2201 S. A Street, Perris. Registration will begin at 7:00 am and the gate will open for the public at 9:00 am. Truck registration (\$20) day of the show. Each registered truck will receive two wristbands that allow entrance for the driver and one guest. Presentation of the wristband will allow a \$5 discount on a train ride ticket. General Admission is free for children under 5 yrs., \$5 for children 5-11 yrs and \$7 for 12 and older. Parking is free.

Take 1-10 east or Route 60 east

or Route 91 east to I-215

(~50 miles from downtown L.A.)

Take I-215 South to Perris

In Perris, exit Route 74 West

Follow Route 74/4th Street

West for 1 mile

Turn left onto "A" Street

From the South (San Diego):

Take the I-15 north to I-215 north

Follow I-215 north to Perris

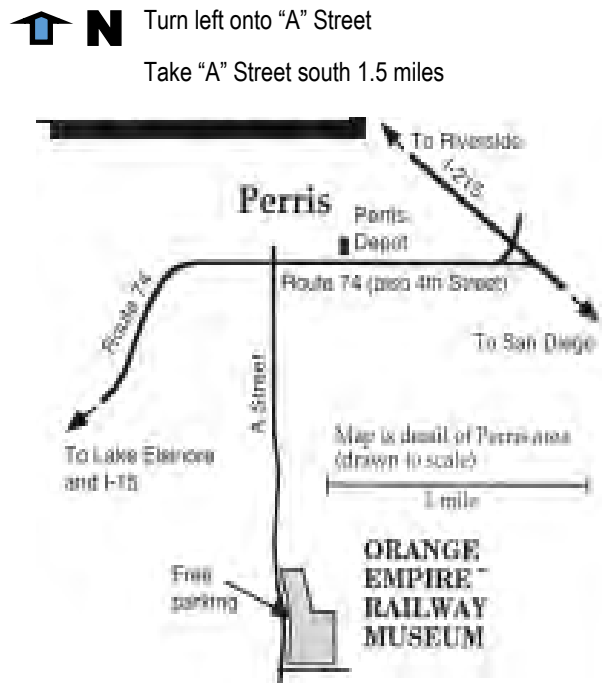
In Perris, exit Route 74 West

ATHS SAFETY RULES

- 1. No person shall operate a vehicle under its own power on the grounds unless the owner knows that its brakes are in good working order and that it is otherwise in safe operating condition. Vehicle operators must have a valid driver's license and must know how to drive the vehicle and safely stop it.
- 2. Each vehicle shall be taken to its designated display area and remain there, except when participating in an event or is moved as required or permitted by Show Management.
- 3. Parked vehicles shall be secured with a chock block.
- 4. All vehicles, machinery, or other loads that are on trucks or trailers must be securely fastened down.
- 5. Each show vehicle shall be equipped with a chock block and an Underwriters Laboratories approved fire extinguisher.
- 6. Fuel tanks shall be capped. Any fuel leakage will be grounds for barring entry of a vehicle or requiring its removal by towing from the display area.
- 7. Vehicle or attached or transported equipment engines shall not be run unless the vehicle owner, or other person authorized by the owner is in close attendance.
- 8. Vehicles must be operated in a cautious and safe manner at all times.
- 9. Every vehicle, including trailers, shall be covered by owners liability insurance, except non-operational vehicles brought in on, and not removed from, trucks or trailers.

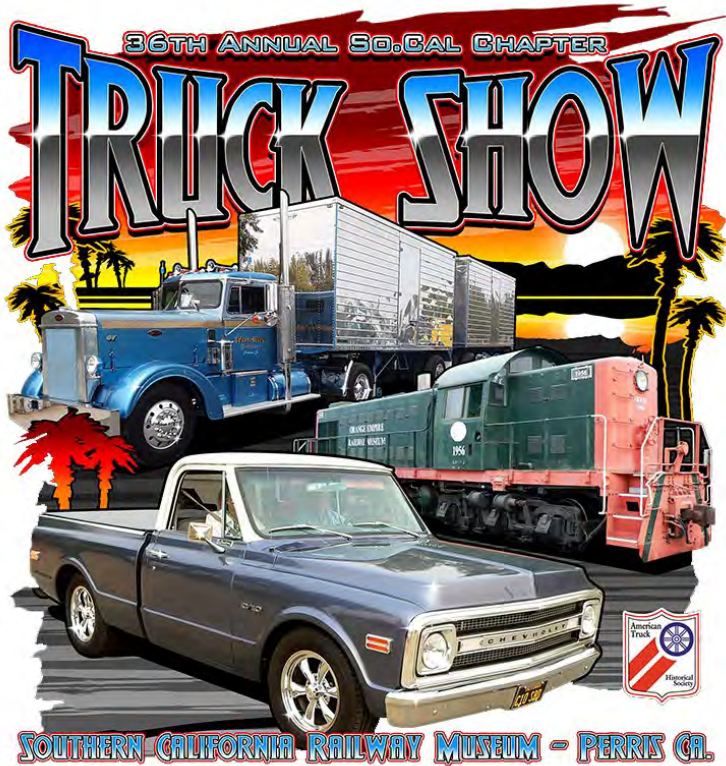
