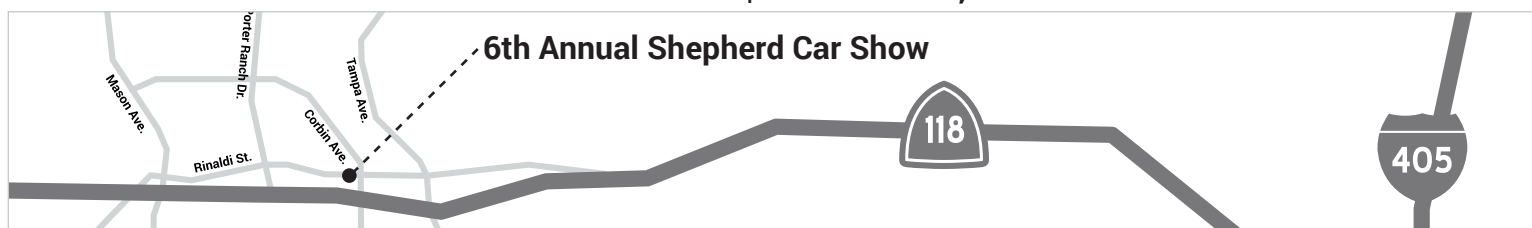

I, on behalf of myself, my heirs, assigns and personal representatives hereby, waive, release, forever discharge, indemnify and hold harmless the Church from any and all liability or claims, including but not limited to liability or claims for bodily injury, property damage, or death arising directly or indirectly from my participation in the Activity or Event, including injuries or losses caused by ordinary negligence, gross negligence and willful misconduct of third parties including other Participants in the Activity or Event. I specifically waive, release and discharge the Church from any damage to my car or any loss of personal property associated with the event. I understand that the Church will not provide security for the event and it is my responsibility to protect my own property. I represent that I maintain personal health and/or accident insurance sufficient to cover any bodily injury and/or damage associated with my auto or the event.

In connection with my participation in the event described above I hereby grant to Church all right, title, and interest of every kind or nature whatsoever, to record, reproduce, display, reproduce, film, tape, digitally produce, or otherwise record, by any means available, copyright, or in any other manner or fashion, use my name and likeness for any purpose whatsoever, including promotion of other events.

Any provision or portion of this Release found to be invalid by a Court having jurisdiction shall be invalid only with respect to such provision or portion thereof, and then only to the extent necessary to avoid such invalidity. The offending provision or portion shall be modified to the maximum extent possible to confer upon the parties the benefits intended thereby. The provision or portion as modified and the remaining provisions or portions hereof shall be construed and enforced to the same extent as if such offending provision or portion thereof had not been contained herein, to the maximum extent possible.

I further agree that any claim or dispute arising from or related to this Release, and the subject matter thereof shall be settled by mediation and, if necessary, legally binding arbitration, in accordance with the Rules of the Institute for Christian Conciliation; judgment upon an arbitration award may be entered in any court otherwise having jurisdiction. If a dispute or claim involves a claim as to which the Church's insurance, or the Church's insurance with respect to Church's officers, directors, elders, employees, agents, volunteer workers, promoters or affiliates, if any, applies, Church's insurer may elect not to submit the dispute or claim to mediation or arbitration as described in this Mediation/Arbitration provision, and unless the parties otherwise agree, this Mediation/Arbitration provision shall no longer be applicable with regard to the part of the dispute or claim as to which the Church's insurance applies. I agree that this Mediation/Arbitration provision shall be the sole remedy for any dispute arising between me, and the Church, and do hereby waive, on behalf of myself, my heirs, assigns and personal representatives, the right to file any legal action against the Church in or before a civil court or agency, except to enforce an arbitration decision.
