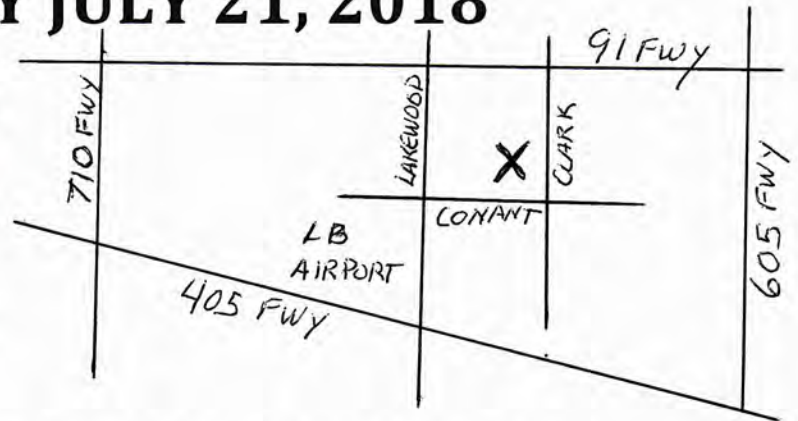

## SALES TAX / SELLER'S PERMIT INFORMATION

### WHO DOES NEED A SELLER'S PERMIT ?

"Generally, a person who makes three or more sales for substantial amounts in a period of 12 months is required to hold a seller's permit. A person who makes a substantial number of sales for relatively small amounts is also required to hold a seller's permit."

"Tax does not apply to a sale of property held or used in the course of an activity not requiring the holding of a seller's permit unless the sale is one of a series sufficient in number, scope, and character to constitute an activity for which the seller is required to hold a seller's permit if the activity were conducted in this state....."

PROPERTY HELD OR USED IN AN ACTIVITY, OR ACTIVITIES REQUIRING THE HOLDING OF A SELLER'S PERMIT. A seller's permit is required of a person engaged in the business of selling tangible personal property. The activity or activities requiring the holding of that permit include, but are not limited to, the acquisition and sale of tangible personal property at retail or resale."

"SERIES OF SALES REQUIRING THE HOLDING OF A SELLER'S PERMIT. When a person not otherwise engaged in an activity requiring the holding of a seller's permit makes a series of sales sufficient in number, scope and character to require the holding of a seller's permit, the gross receipts from all such sales are subject to tax.

(A) NUMBER. Generally the minimum number of sales to require the holding of a seller's permit, is three within any 12 month period.

(B) SCOPE. The extent of the sales measured by their frequency or dollar volume.

(C) CHARACTER. This relates to the similarity in type and value giving effect to the taxpayer's operations. For example, a processor of food products for human consumption is not required to hold a seller's permit for the processing and sale of food products. Sales of used lug boxes, obsolete or used machinery, food handling and similar items are of a character that three or more sales of sufficient scope will require the processor to hold a seller's permit for this selling activity."

(From Sales Tax Regulation 1595)

In other words, if you are selling 3 or more times a year with sales of substantial amounts, if you are selling merchandise purchased for resale, or if you are making sales "sufficient in number, scope, or character", you must have a seller's permit. See the form below for assistance in getting the proper permit.

### WHO DOES NOT NEED A SELLER'S PERMIT ?

"Tax does not apply to a sale of property held or used in the course of an activity not requiring the holding of a seller's permit unless the sale is one of a series sufficient in number, scope and character to constitute an activity for which the seller is required to hold a seller's permit or would be required to hold a seller's permit if the activity were conducted in this state....."

(From Sales Tax Regulation 1595)

In other words, if you haven't sold or don't intend to sell at 3 or more events in a 12 month period **OR** your sales are **NOT** sufficient in number, scope or character, to meet sales tax requirements, you do **NOT** need a seller's permit.

### IF YOU DO NEED A PERMIT, WHAT DO YOU DO ?

Check the box below marked Seller's Permit.

If you already have a permit at another address, you need to get a permit giving the event address as your **business address**. This may be done by mail. If you don't already have a permit, you may get one at the Board of Equalization office. If this is your first time here and you DO NOT already have a seller's permit, put "Application to be filed" on the form below in the space marked "Seller's Permit Number". This will only be accepted **ONE** (1) time.

### IF YOU DO NOT NEED A PERMIT, THEN WHAT ?

Then check the box below marked "Occasional Seller - Permit Not Required". **YOU** must decide whether or not you are required to have a seller's permit. You are encouraged to consult your attorney or accountant if you are in question.

If you need a temporary seller's permit, contact your local Board of Equalization office or call (562) 466-1694. The business address on your temporary permit should be the event address and the mailing address is your permanent place of business.

OCCASIONAL SELLER'S CERTIFICATION: I AM NOT REGULARLY ENGAGED IN THE BUSINESS OF SELLING PURSUANT TO CALIFORNIA SALES AND USE TAX LAW, I HAVE NOT SOLD AND DO NOT INTEND TO SELL AT 3 OR MORE EVENTS IN A 12 MONTH PERIOD OR MY SALES ARE NOT SUFFICIENT IN NUMBER, SCOPE OR CHARACTER TO BE REQUIRED TO OBTAIN A SELLER'S PERMIT. I AM NOT REQUIRED TO OBTAIN A SELLER'S PERMIT.

I AM NOT SELLING ANY ITEMS, I AM ONLY EXHIBITING, ASSISTING A SELLER, OR OTHER NON-SELLING ACTIVITY.
