Completely stock vehicles of model years 1900 to 1942.

B 1946-1959 Domestics

Essentially stock vehicles of U.S. make, except Corvettes and T-Birds, of the model years 1946 to 1959. Significantly modified vehicles will be classified as Customs.

C 1960-1967 Domestics

Essentially stock vehicles of U.S. make, except Corvettes, GTOs, Pony Cars and T-Birds, of the model years 1960 to 1967. Significantly modified vehicles will be classified as Customs.

D 1968-1979 Domestics

Essentially stock vehicles of U.S. make, except Corvettes, GTOs, Pony Cars and T-Birds, of the model years 1968 to 1979. Significantly modified vehicles will be classified as Customs.

E 1980-2010 Domestics

Stock and modified vehicles of U.S. make, except Corvettes, GTOs, HHRs, PTs, Pony Cars and T-Birds, of the model years 1980 to 2010.

F 1946-1972 Foreign

Essentially stock vehicles of non-U.S. make of the model years 1946 to 1972. Vehicles with significant modifications will be classified as Customs.

G 1973-2010 Foreign

Stock and modified vehicles of non-U.S. make, except Miatas of the model years 1973 to 2010.

H 1964-1975 Pony Cars

Essentially stock AMXs, Barracudas, Camaros, Capris, Challengers, Cobras, Cougars, Firebirds, Javelins and Mustangs of the model years 1964 to 1975. Vehicles with significant modifications will be classified as Customs. Reproductions in stock trim are considered to be stock.

I 1976-2010 Pony Cars

Stock and modified Camaros, Firebirds, Mustangs and Shelbys of the model years 1976 to 2010.

J 1953-1962 Corvettes

Stock first generation Chevrolet Corvettes. Vehicles with modifications will be classified as Custom Corvettes.

K 1963-1967 Corvettes

Stock second generation Chevrolet Corvettes. Vehicles with modifications will be classified as Custom Corvettes



L 1968-1996 Corvettes

Stock third and fourth generation Corvettes. Vehicles with modifications will be classified as Custom Corvettes

M 1997-2004 Corvettes

All fifth generation Chevrolet Corvettes.

N 2005-2010 Corvettes

All sixth generation Chevrolet Corvettes.

O 1953-1996 Custom Corvettes

Modified first to fourth generation Chevrolet Corvettes.

P PT Cruisers

Stock or modified PT Cruisers of all model years.

Q HHRs

Stock or modified Chevy HHRs of all model years.

R Miatas

Stock or modified Mazda Miatas of all model years.

S GTOs

Stock or modified Pontiac GTOs of all model years.

T Thunderbirds

Stock or modified Ford Thunderbirds of all model years.

U Low Riders - Originals

Cars and trucks of any make, model or year, customized in the low-rider style, but generally stock in appearance.

V Low Riders - Customs

Cars and trucks of any make, model or year, customized in the low-rider style, and not stock in appearance.

W 1900-1934 Street Rods

Custom cars and trucks based upon pre-war vehicles of model years 1900 to 1934.

X 1935-1942 Street Rods

Custom cars and trucks based upon pre-war vehicles of model years 1935 to 1942.

Y 1946-1959 Customs

Vehicles other than Corvettes and T-Birds of the model years 1946 to 1959 with significant modifications.

Z 1960-1979 Customs

Vehicles other than Corvettes, GTOs and T-Birds of the model years 1960 to 1979 with significant modifications.
