Introduction

The Recreation Division takes pride in offering its residents a safe, clean, and pleasant environment during the Village Car Show. Therefore, compliance with all of the following Rules and Regulations is mandatory at all times.

Rules and Regulations

CAR OWNER DEFINED

The owner of the vehicle is that person whose name appears on the vehicle registration (the "Owner"). Even if there is more than one name listed on the vehicle registration, only one (1) space will be assigned per vehicle.

GENERAL CONDITIONS

Golden Rain Foundation of Laguna Woods ("GRF") and the Recreation Division ("Recreation") reserve the right, at their sole discretion, to refuse assignment of space to any Owner. The failure of any Owner to comply with these Rules and Regulations, and any amendments here to, may result in the Owner being asked to leave for the duration of the event. Recreation further reserves the right, in its sole discretion, to decline any application or withhold any invitation to reapply for future Car Show events.

SUBJECT TO CHANGE

Rules and Regulations, including fees, terms and conditions, are subject to change without notice. The Owner agrees to comply with any and all changes. It is the responsibility of the Owner to obtain a copy of the current Rules and Regulations. The most current version of the Rules and Regulations may be obtained in the Recreation Division office or at the Information/Directory Booth during the event.

WAIVER OF RIGHTS

The Owner agrees that neither GRF, nor Recreation, are responsible for loss, theft, or damage to any of Owner's property. This waiver does not apply in the case of gross negligence or willful misconduct on the part of GRF or its managing agent.

INDEMNIFICATION

The Owner assumes full responsibility for any bodily injury or property damage arising out of the operation of the Owner's car. Owner further agrees to indemnify, defend, and hold harmless GRF, its officers, directors, employees and agents from any and all liabilities, claims, damages, fines and penalties at Owner's sole expense.

INFORMATION/DIRECTORY BOOTH

The Information/Directory Booth is staffed by Recreation, and can assist with emergencies, missing persons, and general information questions.

OPERATING RULES

All Owners are required to have the following documents on hand at all times:

- (A) Seller's Registration Receipt issued by Recreation**
- (B) Valid Driver's License**
- (C) Car Registration**
- (D) Proof of Current Auto Insurance**

Registered spaces may not be sold, assigned, or transferred by the Owner and may not be occupied by any other person in place of the Owner without prior approval of the Recreation Division.

Only one (1) vehicle which is personally occupied by the Owner will be admitted to the showing area.

The exchanging of spaces is not permitted.

BEHAVIOR

Alcoholic beverages are strictly prohibited. Profanity or harassment of any kind, regardless of to whom it is directed, will not be tolerated.

INCLEMENT WEATHER

If the Village Car Show operates and the Owner chooses to **not** enter the showing area, it will be considered a missed reservation and no refund will be issued. If the Village Car Show does not occur due to inclement weather, REFUNDS will be issued to Owners within three (3) weeks.

SETTING UP

Owners may arrive to set up no earlier than 7:30 a.m, and no later than 8:30 a.m. If Owner arrives at 8:31 a.m. or later, entrance to the event will NOT be permitted and NO refund will be given.

Parking in the aisles is not allowed at any time. Driving inside the showing area is not allowed other than by an Owner entering or exiting his or her assigned space. **For the safety of everyone at the Village Car Show, the maximum speed limit is always 3 MPH.**

Outdoor Space - CH5 Parking Lot

Owners will be required to provide their own tables, canopies, chairs, etc. if needed or desired. No shade, chairs, or tables will be provided by Recreation.

OPERATING

Loud music, sounds or noises which can be heard outside an Owner's assigned space will not be allowed. This includes horns and engines. Engines must remain off for the entirety of the event. Engine revving is not allowed.

Owners may only occupy the space to which they have been assigned. Owners who relocate from their assigned space without authorization from the Recreation Division will be asked to leave the premises immediately.

It is the Owner's sole responsibility to ensure that all poles, canopies, tables, chairs, signs, display materials, and any other items be maintained and secured at all times in a manner to prevent or avoid injury or damage to persons or property under any conditions.

Golden Rain Foundation and Recreation Division assume no responsibility for inspecting or approving the safety conditions of the space occupied by Owner, but at its sole discretion may require on immediate action to correct conditions Recreation Division deems to be unsafe.

ELECTRICITY

Electricity is NOT available.

TRASH

Each space shall be kept clean at all times and all Owners are required to take their trash with them when they leave. If an Owner's space is found to be dirty, or trash is left behind, future space assignments to Owner will be denied and the Owner will be assessed a clean-up charge in accordance with GRF Policy.

EXITING

The Village Car Show officially closes at 12:00 p.m. and Owners MUST stay in full set up operation until that time. Owners will not be allowed to leave their space prior to 12:00 p.m. Owners attempting to leave their space prior to 12:00 p.m, without the authorization of Recreation, will be denied future space assignments may be subject to member disciplinary action. Parking in the aisles is prohibited at all times. Driving inside the showing area is prohibited except at specified times by an Owner setting up or exiting an assigned space. All Owners must leave the premises with their vehicles by 1:00 p.m.

(A) When leaving assigned spaces, Owners must drive slowly and safely toward the nearest exit. Drive only in the aisles and not through showing spaces, whether occupied or empty. Pedestrians always have the right of way. Sounding vehicle horns at pedestrians is prohibited. The maximum speed limit is 3 MPH at all times.

(B) An Owner may leave prior to 8:30 a.m. if the Owner decides for any reason to not continue to participate in the event. In such a case, the Owner must contact the Recreation Division Supervisor in charge to receive a safe escort out of the showing area.

(C) **If an emergency arises** requiring an Owner to leave after 8:30 a.m. but prior to 12:00 p.m., the Owner must contact and obtain the approval of the Recreation Division Supervisor in charge who will arrange for a safe escort to the nearest exit.

*No Owner will be re-admitted after leaving the showing area.
